The regular scheduled meeting of the Board of Trustees of Turtlecreek Township was held on December 24, 2024 at 8:30 a.m. with the following persons:

The meeting opened with Mr. Sams leading the Pledge of Allegiance.

The minutes of the meeting held on December 9, 2024 were received by the Trustees prior to the meeting for review. Since there were no additions or corrections, Mr. Jones moved for acceptance, seconded by Mr. Cropper. All were in favor and the minutes were approved as written.

Department Reports:

#### Fire/EMS:

Chip Rielage, Assistant Fire Chief, informed the Board that 2 medics are now running out of Station 33, that \$340,000.00 in grants have been applied for at the State and Federal levels, Chief Jameson is working from Station 31 organizing the new mobile home and conducting driver training.

Assistant Chief Rielage informed the Board that the Fire Department processed 5 candidates for the through the assessment center for the Battalion Chief position. Robert Edmunds has been selected as the Battalion Chief, has accepted the employment offer and will hopefully be starting work here in February.

Assistant Chief Rielage informed the Board that Captain John Seckel attended a leadership class in December. Captain Seckel stated it was very worthwhile and would recommend the leadership class to others.
